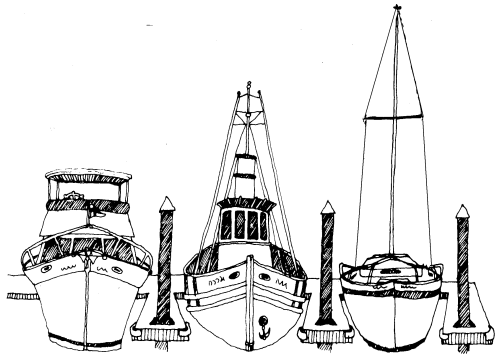

SANTA CRUZ HARBOR BOATYARD:

The Santa Cruz Harbor Boatyard operates as a “Do It Yourself” or DIY facility. Boat owners or independent contractors who have registered with the Port District are permitted to perform vessel repairs and maintenance in the yard.

For your convenience, the boatyard offers a small chandlery stocked with assorted painting and cleaning supplies. Customers are welcome to source painting and repair materials from their preferred supplier, but specific parts and paint supplies may also be special ordered from one of the boatyard’s marine product distributors.

A small selection of rental equipment, including vacuum sanders, is available for use. Tools may be rented at a daily rate and returned to the boatyard after use.

SANTA CRUZ HARBOR BOATYARD HAULOUT SERVICES:

The Santa Cruz Harbor Boatyard offers full-service haulout capabilities, with its new 50-metric ton Marine Travelift. Trained and experienced staff will schedule and assist with the following haulout services:

- Haulouts to 50-metric tons
- One-way and two-way haulouts
- Survey haulouts
- Lay days / yard days

All full-service haulouts include a two strap haul, high pressure wash, and shoring. Additional services are available.

HOURS OF OPERATION:

The Santa Cruz Harbor Boatyard is open daily. All work in the yard must be performed during posted business hours.

INTERESTED IN BECOMING A REGISTERED CONTRACTOR?

Independent contractors must be registered with the Santa Cruz Port District prior to performing any work

at the boatyard. Contractors specializing in marine related services are encouraged to apply for registration.

Registrations are valid for up to one year. Once registered, contractor information will be provided to boatyard customers and published on the Port District’s website.

Applications and insurance requirements may be found on the Port District’s website. Please contact boatyard staff for additional information.

ENVIRONMENTAL COMMITMENT:

The Santa Cruz Harbor Boatyard is committed to providing excellent service, while promoting environmental sustainability.

Boatyard staff monitors and ensures environmental compliance in accordance with permits to protect water quality in both the harbor and Monterey Bay National Marine Sanctuary.

RULES OF THE BOATYARD:

There are several, basic rules which all customers must abide by within the boatyard.

1. Boat stands may only be moved by boatyard personnel.
2. All persons working in the boatyard must be registered at the boatyard office.
3. Hazardous materials spills must be reported immediately and all hazardous materials must be properly stored and disposed of.
4. Boatyard personnel must be notified prior to sanding or applying paint.
5. All Port District and Municipal Ordinances are enforced in the boatyard.
6. No work in the yard except during posted business hours.
